OBJECTIVES

General

Expand and further qualify the professional capacities of historians and other professionals of the social and human sciences, aiming to work with a critical perspective in the different areas associated with the historiographical activity.

Specific

1. To train professionals in the state-of-the art of History.
2. To train professionals able to situate themselves in the spheres of theoretical reflection contributing to theory of History and Historiography.
3. To train professionals with the necessary competences to carry out historical analysis of present and past socio-cultural phenomena of different nature.
4. To train professionals who are able to link scientific knowledge of history with the media and with the teaching of history at different educational levels.

APPLICANTS PROFILE

The master’s degree is meant for:

1. Students devoted to different aspects of History.
2. Students with academic backgrounds other than History, who want to further understand the historical perspective to illuminate their own disciplinary activity.

Candidates must fulfill the following requirements, according to their area of specialty:

- Analysis and synthesis capacities.
- Abstract thinking abilities.
- Ability to concentrate for long periods of time working in archives and libraries.

Specialty areas:

- Basic research: development of research topics within a line of research of the Department of History.

Students coming from disciplines other than History have the option to develop a topic of research within their own discipline, based on a historical approach.

- Teaching or dissemination of history: investigation of proposals related to teaching or dissemination of history at different levels.

Outcomes of research of the different specialty areas may be used as background for the research project of the doctoral program.

GRADUATES PROFILE

Graduates from the Master’s in History have developed different abilities according to the area of specialty they chose:

- Basic research: analysis and synthesis abilities focused on reading historical text (narrative, narrative-conceptual, documental, etc.) and theoretical texts in the context of historical knowledge. Competences to carry out research on the topics of his/her specialty.
- Teaching and dissemination of history: analysis and synthesis abilities focused on reading historical text (narrative, narrative-conceptual, documental, etc.) and dissemination texts and teaching referred to historical

knowledge. They will also be able to design and carry out research projects focused on teaching and disseminating history and/or on the production of materials to make historical knowledge accessible through different media.

FIELD OF WORK

The main areas of work are research, teaching, and dissemination from which multiple activities spring out, such as historical knowledge advancement, teaching of history at different levels, historical advisory for teams or projects, involvement in the organization of museums and cultural institutions, among others.

LINES OF RESEARCH

1) Theory of History and Historiography

Seeks to generate and disseminate rigorous knowledge in the Theory of History and Historiography from the historiographic point of view. It endeavors to formulate a theoretical reflection on History, on the basis of praxis, with the objective of illuminating the historiographic activity.

2) Rhetoric construction of reality: The Society of Jesus

It studies the transition of a rhetorical culture (premodern) to a scientific culture (modern), focusing on the strategies of the Jesuits with during the 16th, 17th, 18th centuries, in different spaces of communication or discursive genres: education, literature, devotions, theatricality, hagiography, among others.

3) History of Present Time: Marks of Memory, Spheres of Experience a History of Emotions

Its objects of study are the processes by which historical memory operates in the configuration of the spheres of experience through the order of emotions, in the delimited framework of present-day history. It studies the impact of modernization processes in Mexico during the 19th and 20th centuries, specifically the forms of socio-cultural resistance, the construction of public imaginaries, the Mexican political culture in the 20th century, Catholic thinking and organizations, and the processes of the creation of identities.

4) Hispanic-Lusitan World

Analyzes the sociocultural processes in the Hispanic world, seen as a geographic and spatial cluster sharing a political, economic and cultural project based on the religious definition of a Catholic monarchy. Its topics analyze the structures of power, the social organization and functioning and the cultural and religious aspects of the Hispanic-Lusitan world, from the 15th century to the beginning of the 19th century.

The program is comprised by **96 credits**, which must be accredited in **two years (four school periods)**.

ADMISSION PROCEDURES

Applicants must deliver the following documents:

1. Original birth certificate.
2. Original and copy of B.A. certificate in the field of History or related fields.
3. Copy of professional license.
4. Updated Curriculum Vitae (without evidence documentation).
5. Statement of Purpose declaring the intention of studying the Master's Program. The format is free and must be directed to Dr. Laura Pérez Rosales, coordinator of History Graduate Programs. Contact: laura.perez@ibero.mx
6. Deliver a 3 to 5-page document on the topic of research of interest, or a draft project proposal, including issues of investigation, objective and the relevance to carry it out during the Master's program.
7. A copy of the B.A. thesis or of a research work completed during the B.A.

The candidate must deliver the following evaluations:

- Textual analysis and writing skills
- National Graduate Admission Exam, EXANI III.
- Academic interview with a committee of professors.
